AUTHORIZATION TO ACCEPT A DECLARATION OF RESTRICTIONS FOR APPLICATION NO. 98-380, CAMILE GILBERT, TRUSTEE, FOR A VOLUNTARY CONTRIBUTION IN ADDITION TO EDUCATIONAL FACILITIES IMPACT FEES

Camile Gilbert, Trustee, (applicant), is requesting a district boundary (land use) change from GU (interim) to RU-1M(a) (single-family modified) for 30 acres located at the southeast corner of S.W. 56 Street and S.W. 159 Avenue (see attached location map). The proposed development of 114 units is consistent with the Miami-Dade County Comprehensive Development Master Plan (CDMP) and is within the current Urban Development Boundary.

The estimated student population generated by this application is 63 students. The schools that will be impacted are Bowman Foster Ashe Elementary School (34 students - permanent utilization of 111%), Howard A. Doolin Middle School (15 students - permanent utilization of 146%), and G. Holmes Braddock Senior High School (14 students - permanent utilization of 158%). The impacted feeder pattern is G. Holmes Braddock Senior High, with an overall feeder pattern utilization of 126% (see attached analysis).

Pursuant to established negotiating procedures, a Management Team meeting was held on December 11, 1998, to negotiate with the applicant. Based on these negotiations and in order to mitigate the impact of this proposed 114-unit development, the applicant has proffered a Declaration of Restrictions (Declaration) to benefit the Board by donating funds in the amount of \$90,000. Should a different number of units ultimately be approved, the donation will be proportionately modified consistent with the impact. Such payment will be made in addition to impact fees (estimated to be \$205,200, based on the countywide average impact fee). The entire contribution is due prior to final plat approval. The Declaration places no restriction on the expenditure of the contribution by the Board.

The Declaration will be reviewed by the School Board Attorney's Office.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida, authorize the acceptance of a Declaration of Restrictions for Application No. 98-380, Camile Gilbert, Trustee, for a voluntary contribution in addition to educational facilities impact fees, under the terms and conditions set forth above.
