**SUBJECT: AWARD OF BID #097-XX02 – PAINT: APPROVED, NON-STOCK**

The purpose of this bid, opened on October 20, 1998, is to establish a contract, to purchase, at firm unit prices, approved non-stock paint, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 49 vendors sent bid forms or card notices of this advertised bid, 31 responded with 13 bids meeting specifications, (not all vendors bid all items) and 18 no bids.

No bids were received for items 1, 13, 14, 16, 19a, 19b, 27a, and 27b. The recommendation reflects that these items be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13-3C-1.111 - Bidding Process—Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
