## SUBJECT: GRANT OF EASEMENT TO BELLSOUTH TELECOMMUNICATIONS, INC., AT THE JOSE MARTI MIDDLE SCHOOL SITE

In order to install and maintain a Controlled Environment Vault (CEV), BellSouth Telecommunications, Inc. (BellSouth), has requested a 20' x 30' easement (600 square feet), be granted on the northwest corner of the Jose Marti Middle School site (see attached location map). The CEV is a precast concrete and steel vault buried below ground, and is approximately 10 feet high, 7 feet wide and 17 feet long. The above-ground portion of the structure consists of a hatch and an air-conditioning unit that measures approximately 6 feet wide, 6 feet long and 4 feet high. The CEV will house fibre-optic equipment which will increase the capacity of telephone call transmissions in the neighborhood. In addition, the school's phone and management information systems will be enhanced as a result of being connected to vault. The market value of land in the surrounding area is approximately \$6 per square foot (a total of \$3,600 for the easement area). However, BellSouth will pay the Board \$12 per square foot for the said easement (a total of \$7,200 for the easement area), which represents two times its market value.

BellSouth, at its sole cost and expense, will restore the installation area to its original condition, beautify the easement area with shrubbery, maintain the outside appearance of the CEV and provide for periodic landscaping of the easement area. BellSouth will indemnify the Board for all personal injury claims and any real or personal property damage claims arising from its use of the easement area.

The said easement area is legally described as:

The North 19.98 feet of South 130.00 feet, of the East 29.98 feet of the West 54.98 feet of Tract 13, CHAMBERS LAND COMPANY'S SUBDIVISION, according to the Plat thereof as recorded in Plat Book 2 at Page 68 of the Public Records of Miami-Dade County, Florida. Where the West line of Tract 13 is a line 10.00 feet Easterly of and parallel with the centerline of West 24th Avenue. Said lands lying in and being in the City of Hialeah, Florida.


The grant of easement document has been reviewed by the School Board Attorney's Office and the Office of Risk and Benefits Management. The principal of Jose Marti Middle School and the Region Superintendent for Region I recommend approval of the grant of easement. Facilities Planning and Construction and the Department of Safety, Environment and Hazards Management are in agreement with the proposed grant of easement.
