SUBJECT: AWARD OF CONTRACT TO EVANS ENVIRONMENTAL & GEOLOGICAL SCIENCE & MANAGEMENT, INC. / EMSL ANALYTICAL, INC. (A JOINT VENTURE), AS ASBESTOS TECHNICAL CONSULTANT / TESTING LABORATORY (ALTERNATE/QUALITY CONTROL).

Staff has completed the selection process for Asbestos Consulting and Testing Services firms, to enter into term contracts for a two (2) year period, to provide services to the Department of Asbestos Management.

Requests for Proposals were issued and advertised and four (4) firms responded and were interviewed by the Selection Committee. From those firms, two (2) were selected as Primary Laboratories/Consultants and a third firm was selected as Alternate/Quality Control Laboratory/Consultant, in the ranking order shown below:

There is no guaranteed minimum compensation under the agreement. The Asbestos Consultant/Testing Laboratory will maintain at least a \$1,000,000 blanket Professional Liability Insurance Policy for the term of the contract.

RECOMMENDED: That The School Board of Miami-Dade County, Florida award a contract to Evans Environmental & Geological Science & Management (EE&G), Inc./EMSL Analytical, Inc. (A Joint Venture), for the Board, to be compensated based on the negotiated unit prices, during a two (2) year period, commencing on June 20, 1999 and terminating on June 19, 2001.
