SUBJECT: REQUEST FOR AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF EDUCATION FOR A COMMUNITY SERVICE GRANT FOR WLRN-FM, JULY 1, 1999 – AUGUST 31, 2000

**STRATEGIC PLANNING GOAL: IX - COMMUNITY/HOME/PARENT/SCHOOL/
BUSINESS PARTNERSHIPS**

During the 1998-99 school year, the Florida Department of Education provided a Florida Community Service Grant, in the amount of \$110,662, to support the programming and production on WLRN-FM. During the 1999-2000 school year, the School Board will be eligible for a Radio Community Service Grant in the amount of \$110,662.

The funds provided by this grant will be used to continue the employment of one host/producer and two assistant writer/producers, and one associate writer/producer. Salary projections based upon current schedules indicate that the funds available in this grant will be less than will be needed to maintain the current level of full-time staffing. Friends of WLRN, Inc., will provide the additional funds.

No local funds are required.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the Florida Department of Education, in the amount of \$110,662, for a Community Service Grant for WLRN-FM, July 1, 1999 – August 31, 2000; and
2. Financial Affairs to establish appropriations in the amounts approved by the granting agency; such appropriations to be reported periodically to the Board.
