The construction budget for this project is \$1,871,000. The Base Bid of the low bidder is 3.1% over the budget.

This project includes Minority Business Enterprise Subcontracting Assistance Levels.

Advertised bids received and opened on June 29, 1999 by The School Board of Miami-Dade County, Florida have been tabulated and analyzed as follows:

Description

This project is for the new construction of seven Primary Classrooms, four K-Classrooms, Administrative Area, Covered Play Area, Satellite Kitchen and other support spaces.

Deductive Alternates

- Alternate No. 1- Landscaping.
- Alternate No. 2- Deduct cost of access road, fence and sidewalks.
- Alternate No. 3- Deduct cost of covered walkway to bus stop.

This project is scheduled for substantial completion within 240 calendar days of the contract, or on April 22, 2000.

The Project Architect, Gili-Mcgraw Architects recommended award of the contract to the low bidder, Carivon Construction Co.

Fifty pre-qualified contractors were notified of this project and five firms picked up plans and specifications.

This project was bid with M.B.E. subcontracting assistance levels of 14% African-American and 6% Women. The recommended contractor has submitted the following M/WBE subcontractors as participants in this project which were reviewed for compliance with overall M/WBE assistance levels of 20%.
