SUBJECT: RENEWAL OF BID #285-VV07 – ON-SITE REFUELING OF VEHICLES

The purpose of this bid, opened on May 12, 1998, was to establish a contract, to purchase, at a firm service charge, with escalation/de-escalation fuel charges, based on the Oil Price Information Service (OPIS) average price, quantities, as may be required, of on-site refueling of vehicles, for the Department of Transportation and Maintenance and Operations. The terms of agreement, as contained in the subject bid, awarded by the Board on July 22, 1998, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be renewed for one (1) additional one (1) year period. The contract is currently in its initial year. The awardee has agreed to renew for the final one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the lower prices, to benefit from fixed prices during the next twelve (12) months, since the Consumer Price Index (CPI) indicates an increase of 2.2%.
