SUBJECT: PARTIAL AWARD OF BID #228-XX09M/WBE – VACUUM CLEANERS

The purpose of this bid, opened on June 6, 1999, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of vacuum cleaners, for various schools. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. This bid is a Minority/Women Business Enterprise (M/WBE) set-aside for African American/Women-owned and operated businesses. Of 70 vendors sent bid forms or card notices of this advertised bid, 18 responded, with 15 regular bids (not all vendors bid all items), 1 non-responsive bid (vendor is suspended from doing business with M-DCPS) and 2 no bids.

Item 7 - Wet/dry vacuum, is being held for further evaluation and will be awarded at the Board meeting of October 20, 1999.
