**SUBJECT: TERMINATE AND RE-AWARD OF ITEMS 24 AND 84 AND AWARD OF
ITEM 27 ON BID #236-XX03 -- FOOD ITEMS: FROZEN AND
REFRIGERATED**

This bid was awarded, by the Board on July 14, 1999, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of frozen and refrigerated food items, for use in the Food Service Program of the Department of Food and Nutrition.

Subsequent to the award of this bid, further review found that in the original evaluation of the bid, one vendor's bid was inadvertently omitted, and was, therefore, not considered in the evaluation process. The recommendation reflects the inclusion of that vendor's bid in the award evaluation process and the termination and re-award of the referenced items.
