The construction budget for this project is \$320,000. The Base Bid of the low bidder is 6.9% under the budget.

This project has been designated as a set-aside for a Minority owned and operated firm.

Advertised bids received and opened on July 6, 1999 by The School Board of Miami-Dade County, Florida have been tabulated and analyzed as follows:

Description

This project is scheduled for completion within 210 calendar days of the contract, or on March 23, 2000.

The Project Architect, Brown & Brown Architects, recommended award of the contract to the low bidder, C & F Decorating Services, Inc.

Fifty contractors were notified of this project and five firms picked up plans and specifications.

This project was limited to a Minority owned and operated business. The Division of Business Development and Assistance ascertained that the low bidder met the certification requirements as an African-American owned and controlled business enterprise.

The Principal/Owner of C & F Decorating Services, Inc. is Mr. Frico Corriolan.
