SUBJECT: AWARD OF BID #221-XX03 - COMMERCIAL REFRIGERATORS AND FREEZERS

The purpose of this bid, opened on May 25, 1999, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of commercial refrigerators and freezers, for use in the Food Service Program of the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 66 vendors sent bid forms or card notices of this advertised bid, 14 responded, with 10 bids meeting specifications (includes 4 bids meeting individual item specifications, but not all item specifications; not all vendors bid all items) and 4 bids not meeting specifications. The award of this bid, based on approved alternate products, has resulted in a potential savings to the Board of approximately \$142,926.

Inasmuch as items 1A through 10A are alternates for other items being recommended for award, it is recommended that all bids received for these items be rejected.
