SUBJECT: RENEWAL OF BID #094-VV10 – PEST CONTROL SERVICES – FOOD SERVICES AND HOME LABS

The purpose of this bid, opened on October 16, 1997, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of pest control services, for school cafeterias and home economic laboratories. The terms of agreement, as contained in the subject bid, awarded by the Board on November 19, 1997, and renewed on November 18, 1998, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be renewed for one (1) additional one (1) year period, and if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its first renewal period. The awardee has agreed to renew, for the final ninety (90) day renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional ninety (90) day renewal period, at the current prices. Staff is in the process of revising specifications. This ninety (90) day renewal is to provide continuity of services during this period.
