**SUBJECT: RENEWAL OF BID #083-XX07 – REPAIR OF HEAVY DUTY TRUCKS
AND SCHOOL BUSES**

The purpose of this bid, opened on August 20, 1998, was to establish a contract, to purchase, at firm unit prices and discounts, quantities, as may be required, of heavy duty trucks and school bus repairs, for Miami-Dade County Public Schools. The terms of agreement, as contained in the subject bid, awarded by the Board on October 7, 1998, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid for an additional one (1) year period, at the current labor rates and discounts, to benefit from fixed prices, during the next twelve (12) months, since the Consumer Price Index (CPI) indicates an increase of 1.2%.
