**SUBJECT: PARTIAL AWARD OF BID #046-ZZ05 – ELECTRICAL LIGHTING  
FIXTURES**

The purpose of this bid, opened on September 21, 1999, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of electrical lighting fixtures, for Maintenance Materials Management stock. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 109 vendors sent bid forms or card notices of this advertised bid, 19 responded, with 12 regular bids (not all vendors bid all items) 1 non-responsive bid (vendor on suspended vendor list) and 6 no bids.

Items 5, 6, 8, 12, 14, 15, 18 through 20, 22 and 23 are being held for further evaluation and will be awarded at the Board Meeting of January 12, 2000.
