The purpose of this request is to obtain prior approval of supplemental awards on the following term bid, inasmuch as the estimated requirements, previously awarded by the Board, will be exceeded before the bid term expires.

Bid #180-XX02 – COARSE AGGREGATES, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of coarse aggregates, for Maintenance Materials Management stock, during the term of the bid, effective May 12, 1999, through May 11, 2000. This supplemental award is requested due to unplanned projects requiring asphalt to be installed at various portable locations throughout the district. Last contract usage averaged \$3,595.46 per month, while this year's usage has averaged \$8,625.56 per month. The supplemental amount requested is based on the average monthly expenditure amount, times the twelve (12) month contract period, minus the original award amount.
