**SUBJECT: AWARD OF BID #093-ZZ03 – VENDING MACHINE PILOT PROGRAM  
– EIGHT (8) SENIOR HIGH SCHOOLS**

The purpose of this bid, opened on November 9, 1999, is to establish a contract, at a firm annual access fee per senior high school location, paid to Miami-Dade County Public Schools, to implement a vending machine pilot program, at eight (8) senior high schools. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 73 vendors sent bid forms or card notices of this advertised bid, 23 responded, with 17 bids meeting specifications (not all vendors bid all items), 1 bid not meeting specifications and 5 no bids.
