SUBJECT: RENEWAL OF BID #142-VV01M/WBE – ARMED SECURITY GUARD SERVICES III

The purpose of this bid, opened on October 30, 1997, was to establish a contract, to purchase, at firm unit prices, services, as may be required, of armed security guards, at various locations. The terms of agreement, as contained in the subject bid, awarded by the Board on December 10, 1997, and renewed on December 9, 1998, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its first renewal period. The awardees have agreed to renew for the second one (1) year renewal period, by letter, on file. The terms of the bid allowed the awarded vendors to request an increase in the hourly labor rate based on the local Consumer Price Index (CPI). Delad Security, Inc. has requested an increase based on the CPI of 4.1%, Vanguard Security, Inc. requested an increase of 3% and Gabriel Security, Inc. requested an increase of 5%, but will receive 4.1%, the maximum allowed according to the CPI. It is considered to be in the best interest of the Board to renew this bid for an additional one (1) year period, at the adjusted prices, to maintain continuity of service at the best possible price.
