SUBJECT: REQUEST FOR APPROVAL OF SUPPLEMENTAL AWARD ON TERM BIDS

The purpose of this request is to obtain prior approval of a supplemental award on the following term bids, inasmuch as the estimated requirements previously awarded by the Board, will be exceeded before the bid terms expire.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, **APPROVE** the supplemental award on the following term bids, inasmuch as the estimated requirements previously awarded by the Board, will be exceeded before the bid terms expire.

Bid #228-XX09M/WBE – VACUUM CLEANERS, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of vacuum cleaners, for various schools, during the term of the bid, effective September 8, 1999, through September 7, 2000. This supplemental award is requested due to increased usage. Vacuums are being purchased by individual schools and Furniture, Fixtures and Equipment, for new school openings. Last contract usage averaged \$3,426.52 per month, while this year's usage has averaged \$6,164.31 per month. The supplemental amount requested is based on the average monthly expenditure, times the twelve (12) month contract period, minus the original award amount, plus \$9,047.42 in pending requisitions.

Bid #105-XX05 – ELECTRICAL WIRING DEVICES, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of electrical wiring devices, for Maintenance Materials Management stock, during the term of the bid, effective June 23, 1999, through August 31, 2000. The requested supplement includes increased usage by Maintenance and Operations, E-Rate purchases. Last contract usage averaged \$3,584.07 per month, while this year's stock usage has averaged \$12,505 per month, plus \$41,518.77 in planned E-rate projects for classrooms and offices.

The supplemental amount requested is based on the average monthly expenditure, times the thirteen (13) month contract period, plus the E-Rate stock requirement, minus the original award amount.
