**SUBJECT: TERMINATE AND RE-AWARD OF ITEMS 11 AND 55 ON
BID #053-ZZ07 – SCHOOL BUS ROUTES FOR APPROVED PRIVATE
SCHOOL BUS COMPANIES**

This bid was awarded by the Board on August 25, 1999, to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of school bus routes, for the Department of Transportation Vehicle Maintenance.

Item 11 – Route 4606 and Item 55 – Route 7602 were awarded to M&M Marroquin Bus Services, Inc., of Miami, Florida, and Bestway Bus Service, Inc., of Miami, Florida, respectively. Subsequent to the award, the State of Florida, Division of Administrative Hearings, issued an order recommending the award of Items 11 and 55 to J. Ruiz Bus Service, Inc., of Hialeah, Florida, and to A. Oliveros, Inc., of Hialeah, Florida, respectively.

The below recommendation reflects that the Board terminate and re-award the routes, pursuant to the recommended order.
