SUBJECT: RENEWAL OF REQUEST FOR PROPOSAL #263-XX10 – COUNSELING SERVICES IN TWENTY PROGRAMS WITH FULL-TIME CLASSES FOR EMOTIONALLY HANDICAPPED AND SEVERELY EMOTIONALLY DISTURBED STUDENTS

The purpose of this Request For Proposal, opened on May 11, 1999, was to establish a contract, at a firm unit price, to provide weekly group and/or individual counseling to students assigned to full-time programs for the emotionally handicapped, for the Division of Exceptional Student Education. The terms of agreement, as contained in the subject proposal, awarded by the Board on June 23, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew, for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this proposal, for an additional one (1) year period, at the current prices, to benefit from fixed prices during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI) indicates an increase of 3.7%.
