**SUBJECT: RENEWAL OF BID #265-XX06 - COSMETOLOGY FURNITURE,
EQUIPMENT AND SUPPLIES, CATALOG DISCOUNT**

The purpose of this bid, opened on May 18, 1999, was to establish a contract, to purchase, at firm discounts, quantities, as may be required, of cosmetology furniture, equipment and supplies, for various locations. The terms of agreement, as contained in the subject bid, awarded by the Board on July 14, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for one (1) additional one (1) year period. The contract is currently in its initial year. The awardees have agreed to renew for the final one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed discounts during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI) indicates an increase of 3.7%.
