SUBJECT: RENEWAL OF BID #012-ZZ03 - SNACK CAKE PRODUCTS

The purpose of this bid, opened on June 24, 1999, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of various items of snack cake products, for the Food Service Program of the Department of Food and Nutrition. The terms of agreement, as contained in the subject bid, awarded by the Board on August 25, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of School Food Service System, Inc., formerly Don Greene Poultry, Inc., of Miami, Florida, the awardee for Item 5 - Fudge brownies, Item 6 - Peanut butter cake roll/bar, Item 12 - Honey bun, Item 16 - Crème filled cup cake, Item 17 - Cinnamon raisin bun, and Item 18 - Bear claw danish, and McKee Foods Corporation, of Collegedale, Tennessee, the awardee for Item 2 - Swiss cake roll. Competitive prices will be solicited for these items, pursuant to Board Rule 6Gx13- 3C-1.111 - Bidding Process - Competitive Bidding Requirements, which describes the procedure and guidelines to be used for bidding based on the estimated dollar expenditure. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI) indicates an increase of 3.7%.
