SUBJECT: REQUEST FOR AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF EDUCATION FOR FUNDING A BASIC ALLOCATION GRANT UNDER THE INDIVIDUALS WITH DISABILITIES EDUCATION ACT (IDEA), PART B, AND UNDER IDEA, GENERAL REVENUE FOR THE MULTIAGENCY NETWORK FOR STUDENTS WITH SEVERE EMOTIONAL DISTURBANCE, EFFECTIVE JULY 20, 2000 THROUGH AUGUST 31, 2001

The Florida Department of Education (FDOE) has awarded the Miami-Dade County Public Schools (M-DCPS) a grant for the Multiagency Network for Students with Severe Emotional Disturbance (SED). M-DCPS has received an annual grant award from the FDOE for the Multiagency Network for SED students since 1983. The project, one of 17 statewide, was established as authorized through the enactment of Section 230.2317, Florida Statutes. It is a two-county program which serves a target population of SED students in both M-DCPS and Monroe County Public Schools. M-DCPS is the grantee and fiscal administrative agent for the project.

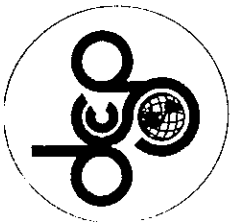
During the 1999-2000 school year, M-DCPS received a basic allocation grant in the amount of \$112,164 and General Revenue funds in the amount of \$38,702, for a total award of \$150,866. For the 2000-2001 school year, a basic allocation grant, in the amount of \$112,164, and General Revenue funds in the amount of \$38,702, for a total amount of \$150,866 is being awarded.

Funds will enable the project to continue previously established program features, including the following: the salary costs for one project manager and one secretary, the Interagency Council, the Monroe Subcommittee, computerized information system, and printing and duplicating.

No local funds are required.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept a grant award from the Florida Department of Education for funding a basic allocation grant under the Individuals with Disabilities Education ACT (IDEA), Part B, in the amount of \$112,164; and under IDEA, General Revenue, in the amount of \$38,702, for a total amount of \$150,866, for the Multiagency Network for Students with Severe Emotional Disturbance, effective July 20, 2000 through August 31, 2001;
2. extend the grant award, at no additional cost, for up to one year, as authorized through official notification from the granting agency, if deemed necessary, in order to fully expend the grant award and thus complete the scope of the project; and
3. Financial Affairs to establish appropriations in the amounts approved by the granting agency; such appropriations to be reported periodically to the Board.

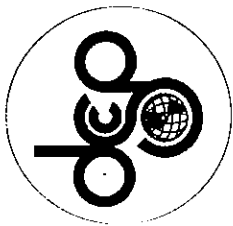
