SUBJECT: RENEWAL OF REQUEST FOR PROPOSALS #026-XX10 – PRE-KINDERGARTEN EARLY INTERVENTION SERVICES FOR CHILDREN WHO MEET LEGISLATIVE ELIGIBILITY REQUIREMENTS FOR THE 1998-99 SCHOOL YEAR

The purpose of the Request For Proposals, opened on July 9, 1998, was to establish a contract, at firm prices, to provide pre-kindergarten services for approximately 2000 at-risk, four-year old children. The children who qualify for free lunch must also have parents/guardians who are working and/or participating in the WAGES (Work And Gain Economic Sufficiency) Programs, for the Division of Early Childhood Programs. The terms of agreement, as contained in the subject proposal, awarded by the Board on July 22, 1998, and renewed on June 23, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its first renewal period. The awardees have agreed to renew for the second one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this proposal, for an additional one (1) year period, at the current prices, to benefit from fixed prices during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of May 2000, indicates an increase of 3.1%.
