SUBJECT: RENEWAL OF BID #011-ZZ03 – FRESH DELIVERED PIZZA, A LA CARTE

The purpose of this bid, opened on June 24, 1999, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of fresh delivered pizza, for the a la carte program at secondary schools, for the Department of Food and Nutrition. The terms of agreement, as contained in the subject bid, awarded by the Board on July 14, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of Emilio's Pizza and Pasta Café, of Hialeah, Florida. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices to benefit from fixed prices during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of May 2000, indicates an increase of 3.1%.
