SUBJECT: RENEW BID #039-VV03 – FOOD SERVICE EQUIPMENT I

The purpose of this bid, opened on August 7, 1998, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of various items of food service equipment, for use in the Food Service Program of the Department of Food and Nutrition. The terms of agreement, as contained in the subject bid, awarded by the Board on October 22, 1997 (partial), March 18, 1998 (balance), renewed on September 9, 1998, and September 8, 1999, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods and, if needed, ninety (90) days beyond the expiration date of the current contract period. The contract is currently in its final renewal period. The awardees have agreed to renew for the final ninety (90) day renewal period, by letter, on file, with the exception of Lee Equipment Company of Hallandale, Florida, the awardee for Item 58 – Chopper, electric and Item 61 - Electric can opener. These items will be purchased, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 – Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure. It is considered to be in the best interest of the Board to renew this bid, for an additional ninety (90) day renewal period, at the current prices, to benefit from fixed prices during the next ninety (90) days, inasmuch as the Consumer Price Index (CPI), as of June, 2000, indicated an increase of 3.7%.
