**SUBJECT: TERMINATE AND RE-AWARD BID #066-ZZ01 – ARMED SECURITY
GUARD SERVICES I**

This bid was awarded by the Board on December 8, 1999, to establish a contract, to purchase, at firm unit prices, as may be required, armed security guard services, for the zone between Gratigny Drive and County Line Road.

Item 1 – Armed security guard level (A), Item 2 – Armed security guard level (B), and Item 3 – Armed security guard level (C), were awarded to Delad Security, Inc., of Miami, Florida. Subsequent to the award, the awardee failed to perform in accordance with the terms and conditions of the bid. Based on the failure of this vendor to perform, it is recommended that the award of these items be terminated and that the vendor lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 -- Performance And Payment Security, Declining A Bid Award, And Bonding Company Qualifications. These items will be re-awarded to the second low bidder meeting specifications.
