SUBJECT: AWARD REQUEST FOR PROPOSALS #260-ZZ10 - PSYCHIATRIC CONSULTATION SERVICES FOR UP TO 16 SCHOOLS WITH FULL-TIME CLASSES FOR SEVERELY EMOTIONALLY DISTURBED STUDENTS

The purpose of this Request For Proposals, opened on July 25, 2000, is to establish a contract, at a firm price, to obtain the professional services of one or more qualified psychiatrists, to provide on-site psychiatric consultation to assist in the diagnosis and programming of students assigned to full-time programs, for severely emotionally disturbed, in elementary and secondary programs, serving severely emotionally disturbed students and other sites, as needed districtwide, for the Division of Exceptional Student Education. This is a term proposal which states that the Board may purchase quantities, as may be required, at the unit price proposed, but is not obligated to purchase any guaranteed amount. Of 95 vendors sent proposal forms or card notices of this advertised proposal, 3 responded, with 2 proposals meeting specifications and 1 no proposal.
