SUBJECT: REQUEST FOR AUTHORIZATION TO ENTER INTO A CONTRACTUAL AGREEMENT WITH THE URBAN LEAGUE OF GREATER MIAMI, INC., FOR FUNDING THE CHILD EMPOWERMENT ZONE'S PARENTAL INVOLVEMENT PROJECT, EFFECTIVE AS OF SEPTEMBER 1, 2000 THROUGH JUNE 30, 2001

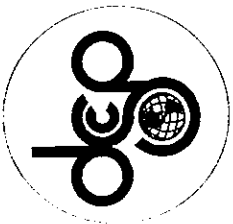
At the May 17, 2000 School Board meeting, the Title VI Innovative Education Program Strategies Grant was approved in the amount of \$2,922,316. Authorization is being requested to enter into a contractual agreement with the Urban League of Greater Miami, Inc., in the amount of \$30,076, for funding the Child Empowerment Zone's Parental Involvement Project. The purpose of the project is to provide assistance and training to parents of low-performing students in Regions III and IV to better understand the methods and responsibilities for supporting improved student achievement and meeting the standards of educational excellence.

Funding for the Title VI grant is included in the 2000-01 Budget in Fund 0420, Object 5310, Location 9616, Program 4522, and Function 9100.

No local funds are required.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to enter into a contractual agreement with the Urban League of Greater Miami, Inc., in the amount of \$30,076, for funding the Child Empowerment Zone's Parental Involvement Project, effective as of September 1, 2000 through June 30, 2001.
