**SUBJECT: AWARD BID #231-ZZ03 – FRESH DELIVERED SPECIALTY ITEMS
A LA CARTE II**

The purpose of this bid, opened on September 12, 2000, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of fresh delivered specialty food items, for the Department of Food and Nutrition a la carte program. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 237 vendors sent bid forms or card notices of this advertised bid, 25 responded, with 7 bids meeting specifications (not all vendors bid all items), 6 non-responsive bids (unsolicited items offered) and 12 no bids.

Inasmuch as no bids were received for Item 2 – Taco, Item 4 – Fried tortilla, and Item 5 – Baked tortilla, the recommendation reflects that these items be rejected. Inasmuch as no bids meeting specifications were received for Item 6 – Assorted burrito, the recommendation reflects that all bids received for this item be rejected. Competitive prices will be solicited for these items, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 -- Bidding Process -- Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
