**SUBJECT: REQUEST FOR APPROVAL OF RESOLUTION NO. 00-45 OF THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, IN SUPPORT OF THE GULFSTREAM MILE RUN TO BE HELD ON FEBRUARY 17, 2001, AT GULFSTREAM PARK, FLORIDA**

The Gulfstream Mile Run is a community-based sports event whereby 48 students from the school systems of Miami-Dade, Broward, and Palm Beach Counties will be participating in a one-mile run on Saturday, February 17, 2001, also known as "Fountain of Youth Day" at the Gulfstream Park on the borderline of Miami-Dade and Broward.

This competitive one-mile run will be holding its fourth annual event in 2001 making it one of the largest attended track and field events in the history of high school sports. The School Boards from Broward and Palm Beach Counties and the Florida State High School Athletic Association support this event.

Prior to the one-mile run finals on February 17th, elimination heats will take place on Tuesday, February 13th. From these heats, 24 boys and 24 girls (8 boys and 8 girls from each of the three counties) will qualify to compete in the finals. Participating schools will nominate runners for competition based on time criteria.

The run itself will take place on the main dirt horse track between regularly scheduled horse races. The main track is one mile in circumference.

The event is available for corporate sponsorship with all the funds raised earmarked for student scholarships. A drive for sponsorship in the three counties is currently underway. The 2000 Mile Run generated more than \$60,000 for all the three counties.

Entertainment will be provided by student musicians, marching bands, and performing artists to the approximate 20,000 expected attendance on February 17.
