**SUBJECT: PARTIAL AWARD OF BID #051-AA03 – FROZEN PIZZA AND PASTA PRODUCTS**

The purpose of this bid, opened on October 26, 2000, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of various frozen pizza and pasta products, for use in the Food Service Program of the Department of Food and Nutrition. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 261 vendors sent bid form or card notices of this advertised bid, 8 responded with 8 bids meeting specifications (includes 3 bids meeting individual specifications but not all specifications; not all vendors bid all items).

Inasmuch as Item 5 - Pizza with cheese and pepperoni, is an alternate for another item being recommended for award, the recommendation reflects that all bids received for this item be rejected. Inasmuch as no bids or no bids meeting specifications were received for Item 13 – Jumbo cheese ravioli, it is recommended that these items be rejected. These items will be purchased, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 - - Bidding Process - - Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

Items 20 through 29 are being held for further evaluation and will be recommended to the Board at the January 17, 2001, meeting.
