SUBJECT: AWARD OF BID #033-AA02 – FIRE ALARM SERVICES CONTRACT

The purpose of this bid, opened on October 19, 2000, is to establish a contract, at firm unit prices, to provide all labor, material and equipment necessary to test, service, inspect, repair and maintain fire alarm systems at various locations, for the Office of Facilities Operations. This is a term bid which states that the Board may purchase quantities, as may be needed, at firm unit prices, but is not obligated to purchase any guaranteed amount. Of 48 vendors sent bid forms or card notices of this advertised bid, 13 responded with 9 bids meeting specifications (not all vendors bid all items) and 4 no bids.

Inasmuch as the only bids received for items 105 through 164, and 282 through 367 are considered excessive, the recommendation reflects that all bids received for these items be rejected in order to permit rebidding, in accordance with Board Rule 6Gx13- 3C-1.111 – Bidding Process – Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.

No bids were received for items 218 through 237. These items will be rebid in accordance with Board Rule 6Gx13- 3C-1.111 – Bidding Process – Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
