SUBJECT: REQUEST FOR AUTHORIZATION TO ACCEPT A GRANT AWARD FROM THE FLORIDA DEPARTMENT OF EDUCATION FOR FUNDING UNDER THE FAMILY LITERACY CORRECTIONS EDUCATION PROGRAM; PROJECT CYCLE: NOVEMBER 30, 2000 THROUGH JUNE 30, 2001

The Bureau of Adult/Vocational, Alternative and Dropout Prevention Programs developed and submitted a grant application to the Florida Department of Education (FDOE) designed to provide literacy services to incarcerated youth at the Miami-Dade County Boot Camp operated by the Miami-Dade County Department of Corrections. Authorization is requested to accept this grant award, in the amount of \$50,000, for family literacy corrections education. The Family Literacy Corrections Education Program will provide supplemental materials, equipment, software, and educational supplies needed by teachers from Miami-Dade County Public Schools for instructional activities at Miami-Dade County Boot Camp.

The Florida Department of Education has verbally stated that the project has been funded; written notification of this grant award is forthcoming. The grant award allows for the reimbursement of expenditures from November 30, 2000.

No local funds are required.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

- 1. accept a grant award from the Florida Department of Education, in the amount of \$50,000, for funding under the Family Literacy Corrections Education Program; Project Cycle: November 30, 2000 through June 30, 2001;
- extend this grant award, at no additional cost, for up to one year, as authorized through official notification from the granting agency, if deemed necessary, in order to fully expend the grant award and thus complete the scope of the project; and
- 3. Financial Affairs to establish appropriations in the amounts approved by the granting agency with such appropriations to be reported periodically to the Board.
