SUBJECT: RENEW BID #132-ZZ10 – CHILLER SERVICE CONTRACTS

The purpose of this bid, opened on January 20, 2000, was to establish a contract, to provide, at firm unit prices, all labor, material and equipment, to furnish monthly air-conditioning chiller maintenance service, including water treatment, for Maintenance and Operations. The terms of agreement, as contained in the subject bid, awarded by the Board on February 9, 2000, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for three (3) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of November 2000, indicated an increase of 3.4%.
