**SUBJECT: APPOINT AND ASSIGN :
COORDINATOR III (2)
REGION FOOD SERVICE**

The following recommendations are made in accordance with the Miami-Dade County Public Schools/Dade County School Administrators' Association labor contract.

These open budgeted positions were approved by the School Board at its meeting of August 23, 2000, Agenda Item A-3.

Ms. Louann G. Glidden, currently a Manager III, Food Service Quality Control, pay grade 39, is recommended for appointment to the open, budgeted position of Coordinator III, Region Food Service, pay grade 42, Department of Food and Nutrition. Ms. Glidden received a Bachelor of Science Degree from Florida International University, Miami, Florida. Ms. Glidden is a Registered Dietician. Since 1997 to the present, Ms. Glidden has been employed by Miami-Dade County Public Schools as Skilled Clerical Worker and a Manager III, Food Service Quality Control, her current position.

Ms. Kay A. Thorpe is recommended for appointment to the open, budgeted position of Coordinator III, Region Food Service, pay grade 42, Department of Food and Nutrition. Ms. Thorpe received a Bachelor of Science Degree from Hampton University, Hampton Virginia; and a Master of Science Degree from Case-Western Reserve University, Cleveland, Ohio. Ms. Thorpe is a Registered Dietician. From 1986 to 1993, Ms. Thorpe was employed by Riverside Hospital, Toledo, Ohio, as a Clinical Dietician and an Administrative Dietician. From 1993 to 1994, Ms. Thorpe was employed by Lucas County Senior Nutrition Program, Toledo, Ohio, as a food Service Director. Since 1995 to the present, Ms. Thorpe has been employed by the Miami Jewish Home and Hospital, Miami, Florida, as a Clinical Dietician, her current position.

These recommendations are the direct result of the Board-approved advertisement and selection process.

RECOMMENDED: That The School Board of Miami-Dade County, Florida, appoint:

1. Ms. Louann G. Glidden, currently a Manager III, Food Service Quality Control, pay grade 39, to the open, budgeted position of Coordinator III, Region Food Service, pay grade 42, 12 months, and assign to the Department of Food and Nutrition, effective March 15, 2001, or as soon thereafter as can be facilitated; and
2. Ms. Kay A. Thorpe to the open, budgeted position of Coordinator III, Region Food Service, pay grade 42, 12 months, and assign to the Department of Food and Nutrition, effective March 15, 2001, or as soon thereafter as can be facilitated.
