**SUBJECT: RENEW BID NO. 160-ZZ04 – COMPUTER NETWORK INTEGRATION SERVICES**

The purpose of this bid, opened on February 29, 2000, was to establish a contract, to provide, at firm unit prices, quantities, as may be required, of computer network integration services, for various locations. The terms of agreement, as contained in the subject bid, awarded by the Board on April 12, 2000, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file, with the exception of ERT Group, Inc., of Fort Lauderdale, Florida. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of December 2000, indicated an increase of 3.4%.
