SUBJECT: RENEW REQUEST FOR PROPOSALS NO. 219-XX10 – RESPIRATORY THERAPIST, REGISTERED NURSE AND LICENSED PRACTICAL NURSE SERVICES

The purpose of this Request For Proposals, opened on April 13, 1999, was to establish a contract, to provide, at a firm unit price, Respiratory Therapist (RT), Registered Nurse (RN) and Licensed Practical Nurse (LPN) services, needed as related support services for the education of handicapped students, for whom such services have been identified as necessary to access education, for the Division of Exceptional Student Education. The terms of agreement, as contained in the subject proposal, awarded by the Board on June 23, 1999, and renewed on May 17, 2000, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its first renewal period. The awardee has agreed to renew for the second one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this proposal, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of January 2001, indicated an increase of 3.7%.
