**SUBJECT: RENEW REQUEST FOR PROPOSALS NO. 191-ZZ10 – COUNSELING SERVICES IN 19 PROGRAMS WITH FULL-TIME CLASSES FOR EMOTIONALLY HANDICAPPED STUDENTS**

The purpose of this Request For Proposals, opened on April 27, 2000, was to establish a contract, at firm prices, to obtain the professional services of qualified individuals or agencies, in the field of mental health, to provide weekly group and/or individual counseling to students assigned to full-time classes for the emotionally handicapped, for the Division of Exceptional Student Education. The terms of agreement, as contained in the subject proposal, awarded by the Board on June 21, 2000, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this proposal, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of January 2001, indicated an increase of 3.7%.
