SUBJECT: AWARD BID NO. 128-AA03 - STORAGE OF DRY, FROZEN AND REFRIGERATED COMMODITIES

The purpose of this bid, opened on March 22, 2001, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of storage services for dry, frozen and refrigerated commodities, for the Department of Food and Nutrition Food Service Program. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 37 vendors sent bid forms or card notices of this advertised bid, 3 responded, with 2 bids meeting specifications (not all vendors bid all items) and 1 no bid.

School Food Service Systems, of Miami, Florida, withdrew its bid for Item 1 – Freezer storage, Item 2 – In-handling charge for item 1, Item 3 – Out-handling charge for item 1, Item 4 – Refrigerated storage, Item 5 – In-handling charge for item 4, and Item 6 – Out-handling charge for item 4, and has elected, by letter, on file, to pay the bid liquidated damages in the amount of \$39,479.88 (check submitted), pursuant to Board Rule 6Gx13- 3C-1.08 – Performance And Payment Security, Declining A Bid Award, And Bonding Company Qualifications.

Inasmuch as no bids were received for Item 1A – Freezer storage, Item 2A – In-handling charge for 1A, Item 3A – Out-handling charge for 1A, Item 4A – Refrigerated storage, Item 5A – In-handling charge for 4A, Item 6A – Out-handling charge for 4A, Item 7A – Dry storage, Item 8A – In-handling charge for 7A, and Item 9A – Out-handling charge for 7A, the recommendation reflects that these items be rejected.
