**SUBJECT: RENEW BID NO. 121-ZZ02 - PETROLEUM POLLUTION SITE
ASSESSMENT REPORTS**

The purpose of this bid, opened on December 7, 1999, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of petroleum site assessment reports, for the Department of Safety, Environment and Hazards Management. The terms of agreement, as contained in the subject bid, awarded by the Board on February 9, 2000, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its initial year. The awardees have agreed to renew for the first one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of March 2001, indicated an increase of 2.9%.
