SUBJECT: TERMINATE AWARD OF ITEMS 1A THROUGH 1C, 4, 5A THROUGH 5C, AND 6 ON BID NO. 305-VV10 – RENTAL OF PORTABLE SANITATION UNITS

This bid was awarded by the Board on September 9, 1998, and renewed on August 25, 1999, and August 23, 2000, to establish a contract, to rent, at firm unit prices, quantities, as may be required, of portable sanitation units, for various locations.

Item 1A – Single seat unit, Item 1B – Single seat unit, Item 1C – Single seat unit, Item 4 – Unit trailer, Item 5A – Handicapped unit, Item 5B – Handicapped unit, Item 5C – Handicapped unit and Item 6 – Holding tank, were awarded to A.E.S. Portable Sanitation, Inc., of Miami, Florida. Subsequent to the award, the awardee failed to perform in accordance with the terms and conditions of this bid. Based on the failure of this vendor to perform, it is recommended that the award of these items be terminated and that the vendor lose eligibility to transact new business with the Board for a period of fourteen (14) months, pursuant to Board Rule 6Gx13- 3C-1.08 – Performance and Payment Security, Declining A Bid Award, And Bonding Company Qualifications. These items will be purchased, as the need arises, pursuant to Board Rule 6Gx13- 3C-1.111 – Bidding Process – Competitive Bidding Requirements, which describes the procedures and guidelines to be used for bidding based on the estimated dollar expenditure.
