WELCOMING UNIVERSITY OF MIAMI PRESIDENT DONNA  
SHALALA TO MIAMI**

University of Miami President Donna Shalala has a long history of contributing to her community and country. As the longest serving secretary of Health and Human Services (HHS), she achieved many accomplishments including bringing health insurance to 3.3 million children, raising immunization rates to record highs, improving nursing home standards and fighting to prevent elder abuse.

An HHS secretary who was an innovator and entrepreneur, Dr. Shalala partnered with businesses and the media in a crusade for awareness and education. Her work resulted in a decline in the use of tobacco and drugs by children and in a decline in teen pregnancies.

Additionally, her fight against Medicare and Medicaid fraud resulted in \$1 billion being recovered since 1996 and \$60 million being saved since 1993. At the end of her government tenure, the Washington Post described her as "one of the most successful governmental managers of all time."

Dr. Shalala was the president of Hunter College before becoming chancellor of the University of Wisconsin-Madison. The first woman to head a Big Ten university, she was named one of the five best managers in higher education by *BusinessWeek*. She then joined the Carter Administration as assistant secretary in the Department of Housing and Urban Development and later became treasurer of the New York City Municipal Assistance Corporation, helping to save that city from the brink of bankruptcy.

It gives me great pleasure to ask the Board to join hundreds of others throughout our community and our state in welcoming Dr. Donna Shalala to Miami.
