**SUBJECT: BALANCE AND CORRECT AWARD ON BID NO. 138-AA01 – SCHOOL OFFICE FURNITURE CATALOG DISCOUNT BID**

The purpose of this bid, opened on May 22, 2001, is to establish a contract, to purchase, at a firm percentage discount from current manufacturers' price lists, quantities, as may be required, of new school/office furniture, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at firm discounts, but is not obligated to purchase any guaranteed amount. Of 163 vendors sent bid forms or card notices of this advertised bid, 85 responded, with 81 bids meeting specifications and 4 no bids.

The award date for Board Item G-75, Board meeting of September 12, 2001 was stated incorrectly. The term of the bid should have read as follows: "Effective September 12, 2001, through September 11, 2003".

Items 38A and 38B - Children's Factory, and Items 271A and 271B - Tot-Mate by Stevens were awarded to School Specialty Furniture and Equipment Division, of Mansfield, Ohio. This vendor submitted alternate bid pages intended, by attached letter, to serve as replacements for its original bid submission. These pages were delivered to the bid box prior to the bid opening as required, when a bid change is desired. Staff inadvertently read the pages as alternate and not replacement pages as the vendor intended. This recommendation will serve to correct the award as submitted to the Board at the September 12, 2001, Board meeting.

Items 131A and 131B – JSI Jasper Seating Company were awarded to Commercial Office Furniture of South Florida, Inc., of Pompano Beach, Florida. Subsequent to the award the manufacturer has sent letters to clarify that although the vendor is an authorized dealer of the Jasper Seating Company, it is not an authorized dealer of the JSI Division. The letter received with the original bid package was for Jasper and not JSI, a division of Jasper Seating Company. Special Condition 14 of this bid required that the vendor submit a letter stating that it is an authorized dealer and failure to do so shall cause the vendor to be considered non-responsive. Therefore, the award for these items should be terminated and awarded to the vendor with the necessary support documentation.
