**SUBJECT: PARTIAL AWARD BID NO. 008-BB04 - COMPUTER PERIPHERALS,
PARTS AND SUPPLIES, CATALOG DISCOUNT**

The purpose of this bid, opened on October 18, 2001, is to establish a contract, to purchase, at firm discounts, quantities, as may be required, of computer peripherals, parts and supplies, for various locations. This is a term bid which states that the Board may purchase quantities, as may be required, at the fixed discount, but is not obligated to purchase any guaranteed amount. Of 830 vendors sent bid forms or card notices of this advertised bid, 60 responded with 46 bids meeting specifications, 4 bids not meeting specifications (minimum order quantity, FOB origin, and cost+), 4 non-responsive bids (no manual signatures), and 6 no bids.

Bids submitted by Azarat Marketing Group, of Miami, Florida, and Ocean Crown Environmental, Inc., of Miami, Florida, are being held, pending certifications, and may be awarded at the January 16, 2002, Board meeting.

No purchases will be made against this term bid unless deemed crucial to the educational process.
