SUBJECT: RENEW BID NO. 089-ZZ07 – AUTO-BODY REPAIRS - CARS, LIGHT AND MEDIUM TRUCKS

The purpose of this bid, opened on January 11, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of auto-body repairs of cars, light and medium trucks, for the Department of Transportation, Vehicle Maintenance. The terms of agreement, as contained in the subject bid, awarded by the Board on February 9, 2000, and renewed on January 17, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be renewed for two (2) additional one (1) year periods. The contract is currently in its first renewal period. The awardees have agreed to renew for the second one (1) year renewal period, by letter, on file. It is considered to be in the best interest of the Board to renew this bid, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of September 2001, indicated an increase of 2.6%.
