SUBJECT: AWARD BID NO. 034-BB07 – TRUCKS, MISCELLANEOUS

The purpose of this bid, opened on January 10, 2002, is to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of miscellaneous trucks, for various departments. This is a term bid which states that the Board may purchase quantities, as may be required, at the unit price bid, but is not obligated to purchase any guaranteed amount. Of 66 vendors sent bid forms or card notices of this advertised bid, 17 responded (includes one vendor who submitted 2 bids), with 18 bids meeting specifications.
