**SUBJECT: EXTEND CONTRACT NO. 151-ZZ07 – BUS FIELD TRIPS WITHIN
MIAMI-DADE COUNTY – SITE SPECIFIC**

The purpose of the bid, opened on March 28, 2000, was to establish a contract, to purchase, at firm unit prices, quantities, as may be required, of bus field trips to specific sites within Miami-Dade County, for various schools and departments. The terms of agreement, as contained in the contract, awarded by the Board on June 21, 2000, and extended on May 16, 2001, provided, that by mutual agreement between the successful vendors and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardees have agreed to extend for the second one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), as of March 2002, indicated an increase of 1.5%.
