The purpose of the Request For Proposals, opened on June 1, 2000, was to establish a contract, at a firm price, to provide on-site comprehensive health services to approximately 280 teen parents and their babies/toddlers at C.O.P.E. Center North, for the Office of Alternative Education and Dropout Prevention Programs. The terms of agreement, as contained in the contract, awarded by the Board on July 19, 2000, and extended on May 16, 2001, provided, that by mutual agreement between the successful vendor and The School Board of Miami-Dade County, Florida, the contract may be extended for two (2) additional one (1) year periods. The contract is currently in its first extension period. The awardee has agreed to extend for the second one (1) year extension period, by letter, on file. It is considered to be in the best interest of the Board to extend this contract, for an additional one (1) year period, at the current prices, to benefit from fixed prices, during the next twelve (12) months, inasmuch as the Consumer Price Index (CPI), for medical-care services, as of February 2002, indicated an increase of 4.5%.
