**SUBJECT: REQUEST AUTHORIZATION FOR THE SUPERINTENDENT TO ENTER INTO A CONTRACTUAL AGREEMENT WITH MIAMI-DADE COMMUNITY COLLEGE (M-DCC) UNDER THE FLORIDA WORK EXPERIENCE PROGRAM, WHEREBY M-DCC WILL REIMBURSE IN FULL THE SALARIES FOR ITS STUDENTS, IN AN AMOUNT NOT TO EXCEED \$85,000, AND MIAMI-DADE COUNTY PUBLIC SCHOOLS WILL COVER FRS/FICA RETIREMENT COSTS, IN AN AMOUNT NOT TO EXCEED \$14,578, EFFECTIVE AUGUST 29, 2002 THROUGH JUNE 30, 2003**

The Florida Work Experience Program was instituted to introduce eligible students to work experience that will complement and reinforce their educational program and career goals. During the 2001-2002 school year, Miami-Dade Community College (M-DCC) was a grantee institution that contracted with Miami-Dade County Public Schools (M-DCPS) as an employer of part-time eligible students in paraprofessional positions. M-DCPS has been informed that funds will be available for the 2002-2003 school year. M-DCC, the sponsoring post-secondary institution, provides 100 percent of the wages of the students who will be hired as M-DCPS paraprofessional employees. These college students will provide instructional aid primarily to low-income, inner city area elementary and secondary students, as well as adult students lacking basic or functional literacy skills.

M-DCC students are paid an hourly rate equivalent to that of M-DCPS paraprofessionals. Enrollees in the program must meet the requirements set forth under Section 240.404, Florida Statutes, Community Service Learning Project. M-DCC will reimburse M-DCPS for actual salaries up to a maximum of \$85,000. The Schools District's share of the cost is limited to paying FRS/FICA retirement costs, in an amount not to exceed \$14,578.

The appropriation for this item is included in the 2002-2003 Tentative Adopted Budget under Fund 0100, Object 5150, Location 8001, Program 9274, Function 5102.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to enter into a contractual agreement with Miami-Dade Community College under the Florida Work Experience Program, whereby Miami-Dade Community College will reimburse the salaries of college students, in an amount not to exceed \$85,000, and Miami-Dade County Public Schools will cover FRS/FICA retirement costs, in an amount not to exceed \$14,578, effective August 29, 2002 through June 30, 2003.

The appropriation for this item is included in the 2002-2003 Tentative Adopted Budget.
